Is it Art?

The following is taken from an article in the New York Law Journal of



Feb. 13 by Mark Fass and brought to our attention by *Allen Ross* (the text has been edited for the sake of brevity).

A dispute between a photographer and the Orthodox Jew whose picture he took at Times Square and sold ten prints of at \$20,000 to \$30,000 each - turned on the question of whether the photograph is basically commerce or art. As commerce,

the picture would be subject to the restrictions of the right-to-privacy laws; as art, it would not.

Supreme Court Justice Gische ruled the photo is art. New York courts have "recognized that art can be sold, at least in limited editions, and still retain its artistic character," Gische noted. "This analysis recognizes that first amendment protection of art is not limited to only starving artists. ... A profit motive in itself does not compel a conclusion that art has been used for trade purposes." Defendant Philip-Lorca diCorcia's show "HEADS" appeared at the Pace Gallery in Chelsea. The exhibition featured photographs of 17 people taken without their knowledge in New York, Tokyo, Calcutta and Mexico City.

The plaintiff a Hasidic Jew with a deep conviction that the use of his image violates the Second Commandment's prohibition against graven images, learned of the use of his portrait in 2005. He

initiated a proceeding alleging that diCorcia and the catalogue publisher violated his rights to privacy. Gische agreed with the defense, noting that for privacy claims

Gisch commented, "Clearly, plaintiff finds the use of the photograph bearing his likeness deeply and spiritually offensive." The sincerity of his beliefs is not questioned by the defendants or this court. While sensitive to plaintiff's distress, it is not redressable in the courts of civil law. In this regard, the courts have uniformly upheld Constitutional First Amendment protections, even in the face of a deeply offensive use of someone's likeness."

The First 100 Megapixel Sensor

Want bigger? DALSA Semiconductor has fabricated and delivered the world's highest resolution image sensor. The CCD device which measures approximately 4" x 4" has a resolution of over 111 megapixels. It is the world's first imager to break the 100 Megapixel barrier. Fortunately it's not available on a Canon or Nikon.

Leica M Lenses Optimized For Digital

Camera snobs don't despair. Future Leica M lenses will be equipped with a code on the bayonet ring enable the planned digital Leica M camera to recognize the lens type.

Better than ipg

The new Windows Vista operating system will use the Windows Media Photo (.wmp) file format. This format is said to produce smaller and better quality files than jpg but still no match for raw.

A new camera in the Pentax tradition; this time digital

For many years, Pentax produced high quality affordable 35cmm cameras. The 6.1 Megapixel PENTAX K100D with Shake Reduction (SR) system promises to bring that tradition to the digital SLR world with it's remarkably affordable price of \$699 with an 18-55 mm Pentax lens and everything else you would expect in an SLR.



New Nikon Software



New image editing software from Nikon, Capture NX, is available for a free 30-day trial. It handles Nikon Raw files (NEF format) as well as jpegs. I have tried the software and find it to be quite powerful with many features not available in previous versions of Capture and unique to any software. The most significant feature is the use of "control points" that allow you to edit sections of the image to selectively control brightness,

contrast, color balance, etc. without the use of layers. There is a learning curve involved since some functions are unique to this software and many functions are not that intuitive, but the help menus are very good. If you already own Nikon Capture Editor, the upgrade is \$89.99. You can look at the users manual by downloading the pdf file from the Nikon site. It's not Just Canon and Nikon anymore

If you're looking for a SLR and are not invested heavily in Canon or Nikon optics, you should check out the new Samsung and Sony SLRs. These are serious cameras with competitive price tags and excellent performance. The Schneider "kit" lens on the Samsung got rave reviews from Pop photo and both cameras are loaded with features. The Sony takes Konica-Minolta lenses in addition to a new Sony lenses.


Improving digital image quality

The work of a professor at Columbia University has lead to the invention of a new approach to dynamic range on CCD's. This new system exposes neighboring pixels of a CCD at slightly different levels. The idea is that if one pixel is over or under exposed, information, which is "nearly right", can be gathered from a neighboring pixel. "The computed image appears comparable in dynamic range to that produced by a high-end, professional grade digital camera." Slippery Tripod Fix



When you put a long, heavy lens on your camera, does it twist and turn on your tripod no matter how tight you make it? You're not alone. Fortunately there is an easy fix that I will share with you. Cut out a piece of dimpled rubber mat material in the shape of your tripod head and glue it on with contact adhesive or rubber cement. The material is available where they sell shelf-lining products. Your camera will never shift again, even if you don't make it very tight. Caution: the mat will have the effect of shortening the tripod screw by about 1/8" so be sure that you have it engaged well into the camera before letting go.

New Competition Rules

There are important changes to the competition rules. The following highlights the changes, and frequently asked questions.

General: Work must be submitted by 7:30 PM on the evenings of the competitions. Work that has scored 7 or more points at a previous SCC competition is not eligible for other monthly competitions unless it is <u>substantially changed</u> from the original submission. The Competition Chairperson must approve such re-submissions.

Makeup's: One make up is permitted each year for a contest that the member was <u>unable</u> to enter. The makeup must be identified on the label as a 'makeup' along with the month that is being made up. Make up work is not eligible for Print or projected image of the month, but the score will be used in calculating the end of year total score.

Scoring: Scoring will be between <u>5</u> and 9 points. The Print or Image of the month will receive a <u>one-point bonus.</u> The member's best score for each category in each monthly competition will be used to determine the Season High Average awards. High Average Awards (1st, 2nd, & 3rd) are determined using the best 6 monthly scores of the season in each category and class with a minimum of 6 entries. Ties will be broken with the 7th, 8th, and 9th monthly high score, as required. If a tie still exists, the scores for the member's second highest monthly entries will be used until the tie is broken.

Prints: A member may enter up to 3 prints per category and must be the member's own photography. Prints may be made by a lab that is available to the general public but prints made by another individual are not acceptable. This means that the work may be printed by a commercial processor but not altered. The entrant must perform all manipulation and adjustments.

Projection: This category replaces color slides and consists digital files for projection. Projected images are limited to 2 per entrant. *The protocol for digital files will be incorporated into these rules as soon as they become available.* For the 2006-07 season, there will be <u>no Group designations</u>. Images that have been entered as projections cannot be entered as prints.

Black & White Prints: "Black & White" is defined as a monochromatic print, which may contain a single color in a specific, localized area. A color image that has been converted to B&W without any other significant change does not qualify for entry in the Black & White category.
